Alfred Aubry, Gatineau Bus Line owner, purchased the club in 1926. The name was changed to the Gatineau Golf and Country Club in 1929, and, in 2012, it officially re-opened with a championship course designed by renowned Canadian golf architect and player Graham Cooke.

The Gatineau course has a length of 5,001–6,894 yards depending on which of the four teeing areas. Generous landing areas and gentle rolling greens await both tee and approach shots and numerous bunkers have been strategically placed while leaving plenty of trees on the fairways to give definition to each hole. Finally, the Gatineau Golf and Country Club clubhouse has been voted the Best Clubhouse in the region by Flagstick Golf Magazine Readers.



### POPULATION AND ECONOMIC TRENDS AFFECTING THE CANADIAN RETIREMENT SYSTEM

OSFI released the 31st CPP actuarial report as at December 31, 2021, in late 2022. Ms. Frappier will discuss the Office of the Chief Actuary's view on:

- » Canadian population and economic trends reflected in the CPP 31<sup>st</sup> actuarial report
- » Difference of funding between Basic CPP and Additional CPP, and how the population and economic trends affect the sustainability of the base and additional CPP
- » Adverse scenarios that have been introduced in the 31<sup>st</sup> report, including stagnation and climate change

Since December 31, 2021, a lot has happened to the economic environment. Building on Ms. Frappier's discussion, Mr. Mulraine will provide his view on the impact of the change in the environment on Canada's short and longer term economic and population trends and how these trends can affect the pension system in Canada.
